## MIAMI CITY BALLET PREVIEWS THE 2014-2015 SEASON

## 29<sup>th</sup> SEASON HIGHLIGHTS INCLUDE FOUR COMPANY PREMIERES: *SWEET FIELDS* – TWYLA THARP *CARMEN* – U.S. PREMIERE BY RICHARD ALSTON *THE CONCERT (Or, the Perils of Everybody)* – JEROME ROBBINS & A WORLD PREMIERE BY JUSTIN PECK WITH DESIGN BY SHEPARD FAIREY

Miami Beach, FL – Miami City Ballet's 29<sup>th</sup> season promises to be as exciting as ever with programs sure to delight both avid ballet fans and newcomers to the art alike by presenting an impressive array of works -- including four Company premieres. Two of the premieres will be seen for the first time on American soil: *Carmen* as created by British choreographer **Richard Alston** and a new 35-minute work created especially for Miami City Ballet by burgeoning choreographer, **Justin Peck** that will feature original set design by iconic graphic artist **Shepard Fairey.** Combined, these two premieres are likely to be among the most buzzed about debuts of the ballet season.

Marking Artistic Director Lourdes Lopez's second season of programming, Miami City Ballet (MCB) opens at the Adrienne Arsht Center on October 17, 2014 in illustrious fashion with John Cranko's *Romeo and Juliet* (Program I) set to Prokofiev's prized score. Having been only performed once to sold-out crowds during the Company's 25<sup>th</sup> anniversary season, MCB proudly welcomes this timeless tale of love and tragedy beautifully brought to life in the grand tradition of classical ballet.

**Hear the Dance** (Program II) offers something for everyone in a musically inspired line-up celebrating the choreographic masters that are staples of the Company's repertoire: **Paul Taylor, Twyla Tharp**, and of course, **George Balanchine**. Here the breadth of MCB's artistic diversity is on display with three very different works by three of America's most cherished choreographers: Taylor's festive *Mercuric Tidings*, set to the exuberant tunes of Schubert, showcases the great athleticism of MCB dancers; Broadway meets ballet in Tharp's *Nine Sinatra Songs* (a MCB fan favorite) featuring glamorous costuming by Oscar de la Renta; and Balanchine's *Symphony in Three Movements*, set to Stravinsky, highlights some of the most dynamic dance patterns in the neoclassical paradigm.

**Passion and Grace** (Program III) further broadens the horizons of MCB's dancers with two Company premieres including Tharp's superbly sophisticated *Sweet Fields* – an uplifting piece performed to the music of American Shaker hymns sung *a cappella*. This emotionally evocative work may best be simply described as heavenly. The pendulum then swings with its second premiere, a first in the U.S. -- the sultry *Carmen* by Richard Alston. Alston is an acclaimed British contemporary dance choreographer and founder of Richard Alston Dance Company. While Alston is known for his modern choreography, this work is presented in the classical ballet vocabulary. It is a smoldering, flamenco-fueled, 50-minute, adaptation of the classic saga of passion and betrayal performed to the music of Rodion Shchedrin's *Carmen Suite*. Opening this promising program is Balanchine's virtuosic *Allegro Brillante* – a work that beautifully accentuates both ballerina and the *corps de ballet*.

**Points of Departure** (Program IV) draws the 29<sup>th</sup> season to a close with the Company premiere of **The Concert (Or, the Perils of Everybody)**, a delightful piece that so wonderfully captures the inner-thoughts of concertgoers, it is considered Jerome Robbins' comedic work-of-genius, all set to the lively music of Chopin. Also on the bill is a world premiere created

Peck, who recently debuted the critically acclaimed *Chutes and Ladders*, will create an original, large cast, 35-minute piece to Bohuslav Martinů's imaginative *Piano Concerto No. 1*. For the new work Peck is collaborating with **Shepard Fairey**, the celebrated street artist who garnered world-wide attention with his grassroots *Hope* poster. Opening the evening is Balanchine's *Raymonda Variations*, a quintessential ballet that forgoes the original ballet's complicated plot by bringing the dance itself center stage through a marvelous display of solos culminating in one joyous celebration of dance.
